Dr. Bascom went over the functions and duties of the committee.

Mr. Aoki reported on a new Assembly Bill 5 in California and the challenges that this poses for music teachers, and music businesses.

Dr. Bascom asked members of the committee to list schools in the valley where students could possibly be hired at or could do an internship in the future.

It was moved and determined that the committee would serve for 3 years. If a member needs to step down from the committee, they will let Dr. Bascom know.

The findings of the Labor Market Analysis report were shown by Dr. Bascom. A discussion of how a lot of teachers that are running businesses do not show up in this report. The wages are quite low for what most teachers are charging in our valley. Mr. Aoki reported that the top code is a state tax code. He and Mr. Oviedo mentioned that several people to not report their income. Also, Dr. Bascom mentioned that home-based businesses do not show up with a top code, and this is what the majority of what the local music teachers in our valley do.

MTNA and MTAC and their programs and relative program strength were discussed.

The Music Teaching Certificate being added to the Music Department curriculum was discussed along with the goals of the program to offer students the skills to be able to work in music schools and as individual private instructors. After a lengthy discussion, this was referred to and given the support of a committee of eight made up of Heyner Oviedo, Gwen Oviedo, Lori Klatt, Nick Estrada, Astghik Gevorkyan, Lindsey Bascom, Kris Aoki, and Jeremey Bergmann.

It was moved and seconded that Mrs. Bascom would serve as a chairperson.

reported on the suggested schedule of classes that are proposed for the Music Teaching Certificate. Added topics being considered might include a basic accounting, and or business course.

The next meeting is tentatively scheduled for April 2024, on Zoom or at Fresno City College, TBA.
