# Meeting commenced at 6:10PM.

- General College Reports Programs, Accreditations & Upcoming Projects/Initiatives
  - a. Moreno Valley (Laura) Laura gave updates in the business department; they are working on implementing a VITA program and building noncredit courses; developing project management, project maintenance, and facilities maintenance certificates



- b. Norco (Patty) Patty gave updates. Earning ACSPB accreditation. Pathway to Law School, Entrepreneurship programs, Dana is running the VITA program, has taken over the CTECH certification program for students to get certified to become a certified tax preparer.
- c. Riverside(Laneshia) Laneshia discussed collaboration with the non-credit programs; VITA is up and running, new full-time faculty is hired in business and accounting; we have adopted our diversity, mission, and vision statements that has become a model for others.
  - i. Diversity, Mission & Vision Statements Laneshia noted that Ajene would post the details in the chat.
  - ii. Associate Degree for Transfer (ADT)-Law, Public Policy, and Society. ADTs exist to provide a clear pathway to our Cal State colleges. It gives priority admission consideration. Laneshia is taking the lead for this particular program. She's working with Political Science and Administration.
- 4. New organization and function (Ajené)
  - a. Proposed Name from Business Advisory Board to Business Leadership Team (BLT). Ajené shared his screen to discuss the new advisory board model. This body would elect a team lead and co-lead. One face to face meeting, three virtual meetings. For example, Patty and Ajené put together the Entrepreneur program. They ran the program past Entrepreneur advisors, who had much input for change. This board would function as suggesters for new curriculum/programs. Omar and DeeAnne agreed this is a good model. Phil Laure agreed that we should get industry input before designing courses. Ajené asked if there were any concerns. He discussed that there could be some information received from campuses every other month to get feedback from this council before we proceeded with our curriculum.
