Occupation Codes and Descriptions

Currently, there are four occupations in the standard occupational classification (SOC) system related to paralegal studies, and one emerging occupation in the O*NET¹ database of occupational information. The occupation titles, job descriptions, and reported job titles are included in Exhibit 1.

Current and Future Employment

In Los Angeles County, the number of paralegal-related occupations are expected to increase by 4% over the next five years. More than 500 job opportunities will be available annually for this group of occupations through 2021 due to new job growth and replacement need (e.g., retirements). Exhibit 2 contains detailed employment projections data for these occupations. Data collection is underway for the emerging occupation of court clerks (43-4031.01), and is therefore not available yet.

Earnings

In Los Angeles County, the entry-level average wage for occupations related to paralegals is \$14.66 per hour, which is above the MIT Living Wage² estimate of \$13.08 per hour for a single adult. The average annual earnings for this occupation group in the region is \$55,735 per year, assuming full-time employment.

Exhibit 3 contains hourly wages and annual average earnings for these occupations. Entry-level hourly earnings is represented by the 10th percentile of wages, median hourly earnings is represented by the 50th percentile of wages, and experienced hourly earnings is represented by the 90th percentile of wages, demonstrating various levels of employment.

Employer Job Postings

In this research brief, real-time labor market information is used to provide a more nuanced view of the current job market, as it captures job advertisements for occupations relevant to the field of study. Employer job postings are consulted to understand who is employing paralegal-related occupations, and what they are looking for in potential candidates.

To identify job postings related to paralegals, the following keywords/search terms were used: paralegals and legal assistants (23-2011), legal secretaries (43-6012), title examiners, abstractors, and searchers (23-2093), court clerks (43-4031.01), court reporters (23-2091)

Top Occupations

In 2016, there were 4,821 employer postings for paralegal-related occupations. More than half of the postings (60%) were for paralegals and legal assistants (2,899 job postings). There were 4,847 job postings for the same cluster of occupations in 2015, and 3,324 job postings in 2014.

Top Titles

Paralegal Certification is overwhelmingly the most sought after certification by employers (86% of all certifications in demand).


Job-specific skills desired by employers include litigation, legal support, and skills in Microsoft programs.



Advertised Education Levels

Exhibit 8 displays the education level requested by employers in online job ads. The majority of employers were looking for a candidate with a bachelor's degree. Approximately 70% of job postings did not specify a level of education.

Industry Concentration

Paralegal-related jobs in Los Angeles County are most often found in the offices of lawyers industry (77% of total jobs in the industry). Exhibit 9 shows the industries that are the largest employers of paralegal-related occupations in Los Angeles County.

Education and Training

Exhibit 10 shows the typical entry-level education requirement for the occupations of interest, along with the typical on-the-job training, and percentage of workers in the field who hold a community college award or have completed some postsecondary courses.

At least 40% of workers in these occupations have completed some postsecondary coursework, which indicates that these occupations are relevant for community college students.

Currently, there are 13 community colleges in Los Angeles County that train students in paralegal studies. Exhibit 11 displays the headcount and annual average community college awards for each of the colleges training in this field. Between 2012-2015, the total annual average community college awards conferred was 367 (151 associate degrees and 216 certificates) across the program.

Headcount is the actual number of students enrolled, regardless of credit hours. It is also important to note that an award is not equivalent to a single person in search of a job opening, since a student may earn more than one award (e.g. an associate degree and a certificate).

Student Outcomes

The CTE LaunchBoard provides student outcome data on the effectiveness of CTE programs. The following student outcome information was collected from exiters of the Paralegal Taxonomy of Program (TOP) code (1402.00) in Los Angeles County for the 2013-14 academic year.

- The median annual wage after program completion is \$23,971
- 44% of students are earning a living wage
- 64% of students are employed within six months after completing a program

Program Recommendation

This report was compiled by the Los Angeles/Orange County Center of Excellence to provide regional labor market data for the program recommendation of Paralegal (1402.00). This report is to help determine whether there is demand in the local labor market that is not being met by the supply from programs of study (CCC and non-CCC) that align with this occupation group.

Based on the data, the COE has determined there is an unmet need for the paralegal program in the Los Angeles region. Reasons include:

- Paralegal-related occupations are forecasted to increase by 4% over the next 5 years, resulting in over 500 jobs annually
- On average, 367 community college awards were conferred annually between 2012-2015
- Between 40-48% of these paralegal-related workers have completed some postsecondary coursework, signaling that these occupations are relevant for community college students.

Notes

Data included in this analysis represents the labor market demand for positions most closely related to paralegal studies. Standard occupational classification (SOC) codes were chosen based on the national education level required for employment (associate degree and postsecondary certificate) as well as the proportion of current workers who hold a community college award or have had some community college training. This selection process narrows the labor market analysis to the most relevant employment opportunities for students with community college education and/or training.

Traditional labor market information was used to show current and projected employment based on data trends, as well as annual average awards granted by regional community colleges. Real-time labor market information captures job post advertisements for occupations relevant to the field of study and should not be used to establish current job openings, because the numbers may include duplicate job postings or postings intended to gather a pool of applicants. Real-time labor market information can signal demand and show what employers are looking for in potential employees, but is not a perfect measure of the quantity of open positions.
