

## Program Endorsement Brief: 1250.00/Emergency Medical Services

Los Angeles/Orange County Center of Excellence, April 2019

## **Summary:**

The Los Angeles/Orange County Center of Excellence for Labor Market Research (COE) prepared this report to provide regional labor market supply and demand data related to emergency medical services. This report is intended to help determine whether there is demand in the local labor market that is not being met by the supply from community college programs that align with relevant occupations.

The following summarizes key findings from this data brief:

- The number of jobs for emergency medical technicians and paramedics, and ambulance drivers and attendants is projected to increase by 7% over the next five years. More than 500 job openings will be available annually due to new job growth and replacement need (e.g. retirements).
- In the past 12 months, there have been 606 online job postings related to emergency medical services in the region.
- Currently, five colleges have emergency medical services programs.
- Last year, there were no other community college requests for data related to a similar program.
- Between 2015 and 2018, community colleges in the region conferred an average of 133 awards (associate degrees and certificates) in related training programs.

**Occupational Demand** — In Los Angeles/Orange County, the number of jobs for emergency medical technicians and paramedics, and ambulance drivers and attendants is projected to increase by 7%. There will be more than 500 job openings per year through 2023 (Exhibit 1).

**Wages** — As shown in Appendix B, the entry-level wages for emergency medical technicians and paramedics, and ambulance drivers and attendants are lower than the MIT Living hourly wage for one adult in the region (\$14.36 in Los Angeles County, \$15.85 in Orange County). Regional wages are below the statewide averages.

Job Postings — In the past 12 months, there have been 606 online job postings related to emergency medical services. The majority of job postings are for emergency medical technicians and paramedics. Top specialized skills are: patient care, cardiopulmonary resuscitation (CPR), and advanced cardiac life support (ACLS). The top employers, by number of job postings, in the region include: Liberty Ambulance, Ambulnz and Atlas Lift Tech.

**Educational Attainment** — The BLS lists a postsecondary certificate as the typical entry-level education for emergency medical technicians and paramedics, and a high school diploma as the entry-level education for ambulance drivers and attendants. The national-level educational attainment data indicates between 38% and 68% of workers in the field have completed some college or an associate degree. Of the job postings listing a minimum education level, the majority (92%) requested high school or vocational training.

**Community College Supply** — Appendix A shows the annual and average three-year number of awards conferred by community colleges in Emergency Medical Services (1250.00). Currently five colleges have EMS programs, with Mt. San Antonio and East LA conferring the most awards. Last year, there were no other community college requests for data related to a similar program.
