

Program Endorsement Brief: 3007.00/Cosmetology and Barbering Nail Care

Los Angeles/Orange County Center of Excellence, March 2019

Summary:

The Los Angeles/Orange County Center of Excellence for Labor Market Research (COE) prepared this report to provide regional labor market supply and demand data related to nail care. This report is intended to help determine whether there is demand in the local labor market that is not being met by the supply from community college programs that align with relevant occupations.

The following summarizes key findings from this data brief:

- The number of jobs for manicurists and pedicurists is projected to increase by 12% over the next five years. Nearly 1,600 job openings will be available annually due to new job growth and replacement need (e.g. retirements).
- In the past 12 months, there have been 365 online job postings for nail care-related workers in Los Angeles and Orange counties.
- In the region, 11 colleges have cosmetology and barbering programs.
- Between 2014 and 2017, community colleges in the region conferred an average of 825 awards (associate degrees and certificates) in related training programs.

Occupational Demand — In Los Angeles/Orange County, the number of jobs for manicurists and pedicurists is projected to increase by 12%. There will be nearly 1,600 job openings per year through 2022 (Exhibit 1).

¹ Five-year change represents new job additions to the workforce. Annual openings include new jobs and replacement jobs that result from retirements and separations.

Wages — As shown in Appendix B, the entry-level and median wages for manicurists and pedicurists are lower than the MIT Living hourly wage for one adult in the region (\$13.54 in Los Angeles County, \$15.31 in Orange County).

Job Postings — In the past 12 months, there have been 365 online job postings for nail carerelated workers. The majority of job postings were for nail technicians and manicurists. The top three employers, by number of job postings, in the region are: Lak Nail Bar, Nordstrom, and JCPenney.

Educational Attainment — The BLS lists a postsecondary certificate as the typical entry-level education for manicurists and pedicurists. The national-level educational attainment data indicates 30% of workers in the field have completed some college or an associate degree. Of the job postings listing a minimum education level, all requested high school or vocational training.

Community College Supply — Appendix A shows the annual and average three-year number of awards conferred by community colleges in the related TOP code: Cosmetology and Barbering (3007.00). Last year, there were two other community college requests for data related to a similar program.

Note: Cosmetology and Barbering programs prepares students for a variety of personal service occupations, including barbers, hairstylists, theatrical makeup artists, skincare specialists and manicurists/pedicurists. The awards data in Appendix A counts all of these personal service specializations, not only manicurists and pedicurists.
