

Program Endorsement Brief: 2104.40/Alcohol and Controlled Substances Addiction Studies

Los Angeles/Orange County Center of Excellence, December 2018

Summary:

The Los Angeles/Orange County Center of Excellence for Labor Market Research (COE) prepared this report to provide regional labor market supply and demand data related to addiction studies. This report is intended to help determine whether there is demand in the local labor market that is not being met by the supply from community college programs that align with relevant occupations.

The following summarizes key findings from this data brief:

- Middle-skill occupations related to human services (including addiction studies) are increasing by 13% over the next five years, and nearly 4,100 job openings will be available annually due to new job growth and replacement need.
- Over the past 12 months, there were 850 online middle-skill job postings directly related to addiction studies in Los Angeles and Orange Counties.
- Four other related program recommendation requests were received between January and November 2018 from regional community colleges.
- Eleven colleges in the region have existing programs closely related to addiction studies.
- Between 2014 and 2017, community colleges in the region conferred an average of 392 awards annually (associate degrees and certificates) in related training programs.

Occupational Demand—In Los Angeles/Orange County, the number of middle-skill jobs related to human services (including addiction studies) is projected to increase by 13%. There will be nearly 4,100 job openings per year through 2022 (Exhibit 1). It is important to note that these middle-skill occupations (social and human service assistants (21-1093) and community health workers (21-1094) assist clients and resolve problems in a wide variety of human services fields, including substance abuse and/or addiction.

It is also important to note that there are above middle-skill occupations that address addiction studies, such as Substance Abuse and Behavioral Disorder Counselors (21-1011), Mental Health and Substance Abuse Social Workers (21-1023) and Mental Health Counselors (21-1014); however, these mental health occupations typically require a Master's degree and are not included in this report.

Wages—Entry-level hourly wages for middle-skill occupations related to addiction studies in the region are between \$13.47 and \$13.74. Entry-level wages for these occupations are similar to the MIT Living hourly wage for one adult in Los Angeles County (\$13.54) and below the MIT Living hourly wage for one adult in Orange County (\$15.31). Experienced workers earn between \$33.94 and \$35.08 hourly, which is higher than the living wage. Regional wages are above the average statewide wage for this occupation.

Job Postings—There were 850 online middle-skill job postings directly related to addiction studies listed in the past 12 months. The majority of job postings are for substance abuse counselor, counselor, mental health worker, certified counselor and mental health specialist. Top specialized skills are: case management, treatment planning, crisis intervention, rehabilitation and addiction treatment. The top three employers, by number of job postings, in the region are: Tarzana Treatment Centers, Pacific Clinics and Behavior Health Services

Certifications—California law requires that volunteers, interns, or employees of alcohol and drug treatment facilities are registered with a state certifying body. Once registered, workers have five years to become fully certified, which includes education, testing and training.² The California Department of Health Care Services currently recognizes two organizations that register and certify alcohol and other drug counselors in California.³ Appendix C displays the certification organizations, and the minimum requirements for education, testing and training.

Educational Attainment—The BLS lists a high school diploma or equivalent as the typical entry-level education for these occupations. The national-level educational attainment data indicates between 31% and 40% of workers in the field have completed some college or an associate degree. In Los Angeles/Orange County, 76% of job postings request a high school diploma.

Community College Supply—Appendix A shows the three-year average number of awards conferred by community colleges in the related TOP code: Alcohol and Controlled Substances (2104.40). The colleges with the most completions in the region are: Mt. San Antonio, East LA and LA Southwest. Between January and November 2018, there were four other related program recommendation requests from regional community colleges.
