Program Recommendation

This report was compiled by the South Central Coast¹ Center of Excellence to provide regional labor market data for the program recommendation – Business. This report addresses occupations being prepared for by regional Accounting, Business and Commerce, General, and Business Management Programs. This report can help determine whether there is demand in the local labor market that is not being met by the supply from programs of study (CCC and non-CCC) that align with this occupation group.

Key Findings

- In the South Central Coast region, the number of jobs related to Business are expected to **increase** for Financial Managers and **remain steady** for all other occupations considered for this report.
- Business is anticipated to experience a high risk of automation for Bookkeeping, Accounting, and Auditing
 Clerks and Tax Preparers, and a low risk of automation for Accountants and Auditors, Budget Analysts,
 and Financial Managers.
- In 2020 there were 3,522 regional completions and 2,212 regional openings in programs related to the occupations identified as related to Business for this analysis, indicating an **oversupply**.
- Typical entry-level education is a high school diploma or equivalent for Tax Preparers, some college
 no degree for Bookkeeping, Accounting, and Auditing Clerks, and a bachelor's degree for Financial
 Managers, Accountants & Auditors, and Budget Analysts.
- Completers of regional Business and Commerce, General programs from the 2018-2019 academic year had a median annual wage upon completion of \$27,396.
- Completers of regional Accounting programs from the 2018-2019 academic year had a median annual wage upon completion of \$33,548.
- Completers of regional Business and Commerce, General programs from the 2018-2019 academic year had a median annual wage upon completion of \$32,676.

¹ The South Central Coast Region consists of San Luis Obispo County, Santa Barbara County, Ventura County, and the following cities from North Los Angeles County: Canyon Country, Castaic, Lake Hughes, Lancaster, Littlerock, Llano, Newhall, Palmdale, Pearblossom, Santa Clarita, Stevenson Ranch, and Valencia.

Occupation Codes and Descriptions

There are five occupations in the standard occupational classification (SOC) system that were identified as related to Business for this analysis. The occupation titles and descriptions, as well as reported job titles are included in Exhibit 1.

Earnings

In the South Central Coast region, the average wage for the listed occupations is \$29.86 per hour.

Exhibit 3 contains hourly wages and annual average earnings for these occupations. Entry-level hourly earnings are represented by the 25th percentile of wages, median hourly earnings are represented by the 50th percentile of wages, and experienced hourly earnings are represented by the 75th percentile of wages, demonstrating various levels of employment.

Employer Job Postings

In this research brief, real-time labor market information is used to provide a more nuanced view of the current job market, as it captures job advertisements for occupations relevant to the field of study. Employer job postings are consulted to understand who is looking within the field, and what they are looking for in potential candidates. To identify job postings related to Business the following standard occupational classifications were used:

- Median annual wage upon completion of \$33,548.
- 48% of students are employed within a year after completing a program.
- 44% of students attained a living wage within a year of completion.
- +21% change in earnings for completers.
- 58% of students were part time, 6% skill builders, 38% first-generation, and 71% economically disadvantaged.

The CTE LaunchBoard provides student outcome data on the effectiveness of CTE programs. The following student outcome information was collected from current students and exiters of regional **Business and Commerce**, **General programs** (**TOP: 0501.00**) for the 2018-19 academic year.

- Median annual wage upon completion of \$27,396.

- 34% of students **attained a living wage** within a year of completion.
- +32% change in earnings for completers.
- 62% of students were part time, 4% skill builders, 40% first-generation, and 74% economically disadvantaged.

- +21% change in earnings for completers.
- 64% of students were part time, 9% skill builders, 38% first-generation, and 71% economically disadvantaged.

Notes

Data included in this analysis represent the labor market demand for relevant positions most closely related to Business. Traditional labor market information was used to show current and projected employment based on data trends, as well as annual average awards granted by regional community colleges. Real-time labor market information captures job post advertisements for occupations relevant to the field of study and can signal demand and show what employers are looking for in potential employees, but is not a perfect measure of the quantity of open positions. All representations have been produced from primary research and/or secondary review of publicly and/or privately available data and/or research reports. The most recent data available at the time of the analysis was examined; however, data sets are updated regularly and may not be consistent with previous reports. Efforts have been made to qualify and validate the accuracy of the data and findings; however, neither the Centers of Excellence for Labor Market Research (COE), COE host district, nor California Community Colleges Chancellor's Office are responsible for the applications or decisions made by individuals and/or organizations based on this study or its recommendations.
