

Program Endorsement Brief: 1402.00/Paralegal Legal Support Professional

Los Angeles/Orange County Center of Excellence, April 2019

Summary

The Los Angeles/Orange County Center of Excellence for Labor Market Research (COE) prepared this report to provide regional labor market supply and demand data related to legal support occupations. This report is intended to help determine whether there is demand in the local labor market that is not being met by the supply from community college programs that align with relevant occupations.

The following summarizes key findings from this data brief:

- The number of jobs for legal support-related occupations is projected to increase by 3% over the next five years; nearly 3,600 job openings will be available annually due to new job growth and replacement need.
- Over the past 12 months, there have been 6,530 online job postings related to middle-skill legal support occupations in Los Angeles and Orange Counties.
- No other related program recommendation requests were received in 2018 from regional community colleges.
- Nineteen colleges in the region have existing legal office technology and paralegal programs.
- Between 2015 and 2018, community colleges in the region conferred an average of 482 awards annually (associate degrees and certificates) in related training programs.

Occupational Demand — In Los Angeles/Orange County, the number of jobs for legal support-related occupations is projected to increase by 3%. There will be nearly 3,600 job openings per year through 2023 (Exhibit 1).

¹ Five-year change represents new job additions to the workforce. Annual openings include new jobs and replacement jobs that result from retirements and separations.

Wages — Entry-level wages for legal support occupations in the region are between \$10.90 and \$15.12. Entry-level wages for legal secretaries are higher than the MIT Living hourly wage for one adult in the region (\$14.36 in Los Angeles County and \$15.85 in Orange County); however, entry-level wages for paralegals, legal assistants and all other legal support workers are lower than the living wage. Experienced workers earn between \$35.36 and \$41.13, which is higher than the living wage.

Job Postings — There have been 6,530 online job postings for middle-skill legal support professionals listed in the past 12 months. The majority of job postings were for legal assistants, paralegals, legal secretaries, litigation secretaries, and litigation paralegals. Top specialized skills are: litigation, legal support, administrative support, legal documentation, and legal document composition. The top three employers, by number of job postings, in the region are: Kent Daniels and Associates, Ricoh Electronics, and JBA International.

Educational Attainment — The BLS lists an associate degree as the typical entry-level education for paralegals and legal assistants, and a high school diploma for legal secretaries and all other legal support workers. The national-level educational attainment data indicates between 40% and 48% of workers in the field have completed some college or an associate degree. In Los Angeles/Orange County, 76% of job postings request high school or vocational training.

Community College Supply — Appendix A shows the annual and three-year average number of awards conferred by community colleges in Legal Office Technology (0514.10) and Paralegal (1402.00). The paralegal programs with the most completions in the region are: Coastline, Pasadena and Cerritos. Last year, there were no other related program recommendation requests from regional community colleges.
