

Program Endorsement Brief: 0502.00/Accounting Accounting Clerical; Accounting – CPA Track Certificate

Los Angeles/Orange County Center of Excellence, September 2019

Summary Analysis

The Los Angeles/Orange County Center of Excellence for Labor Market Research (COE) prepared this report to provide Los Angeles/Orange County regional labor market supply and demand data related to three middle-skill occupations: billing and posting clerks (43-3021), bookkeeping, accounting, and auditing clerks (43-3031), and payroll and timekeeping clerks (43-3051). Middle-skill occupations typically require some postsecondary education.¹ This report is intended to help determine whether there is demand in the local labor market that is not being met by the supply from community college programs that align with relevant occupations.

Based on the available data, it appears that there is a supply gap for these occupations in the region. Therefore, the COE endorses this proposed program for the following reasons:

Demand:

• Over the next five years, there is projected to be 12,121 jobs available annually in the region due to retirements and workers leaving the field, which is more than the 1,338 awards conferred annually by educational institutions in the region.

Supply:

- All **28 community colleges** in the region that have an accounting program, conferring an average of **1,321 awards annually** between 2015 and 2018.
- Between 2013 and 2016, there were an average of **17 awards conferred annually** in related training programs by **non-community college institutions in the region**.

Occupational Demand

Exhibit 1 shows the five-year occupational demand projections for middle-skill accounting occupations. In Los Angeles/Orange County, the number of jobs related to these occupations is projected to decrease by less than 1% through 2023. However, there will be more than 12,100 job openings per year through 2023 due to retirements and workers leaving the field.

¹ The COE classifies middle-skill jobs as the following:

[•] All occupations that require an educational requirement of some college, associate degree or apprenticeship;

[•] All occupations that require a bachelor's degree, but also have more than one-third of their existing labor force with an educational attainment of some college or associate degree; or

[•] All occupations that require a high school diploma or equivalent or no formal education, but also require short- to longterm on-the-job training where multiple community colleges have existing programs.

Wages—Typical entry-level hourly wages for middle-skill accounting occupations throughout the region are between \$16.41 and \$18.65.³ Entry-level wages for these occupations are higher than the California Family Needs Calculator hourly wage for one adult in Los Angeles County (\$15.04). Entry-level wages for one of the three middle-skill accounting occupations (payroll and timekeeping clerks) is higher than the California Family Needs Calculator hourly wage for one adult in Orange County (\$17.36); wages for bookkeeping, accounting, and auditing clerks, and billing and posting clerks are below the hourly wage in Orange County. Experienced workers can expect to earn between \$24.83 and \$29.17, which is higher than the California Family Needs Calculator wage estimates for both counties. Wage information, by county, is included in Appendix A.

Job Postings—There were 20,354 online job postings related to the three middle-skill accounting occupations listed in the past 12 months. The highest number of job postings were for bookkeeper, accounting clerk, accounts payable clerk, accounts payable specialist, and payroll specialist. The top skills were: accounting, accounts payable/receivable, data entry, bookkeeping, and customer billing. The top three employers, by number of job postings, in the region were: Anthem Blue Cross, Marriott International, H&R Block, Hertz Corp., Anthem Blue Cross, CBRE, and East West Bank. Of the 20,354 online job postings, 37% list a minimum education requirement.

Educational Attainment—The Bureau of Labor Statistics (BLS) lists a high school diploma or equivalent as the typical entry-level education for billing and posting clerks; and payroll and timekeeping clerks; and some college/no degree for bookkeeping, accounting, and auditing clerks. The national-level educational attainment data indicates between 47% and 49% of workers in the field have completed some college or an associate degree. Of the 37% middle-skill accounting job postings listing a minimum education requirement in Los Angeles/Orange County, 68% (5,091) requested a high school diploma and 32% (2,389) requested an associate degree.

Supply

Community College Supply—Exhibit 2 shows the annual and three-year average number of awards conferred by community colleges in accounting (0502.00). The colleges with the most completions in the region are: East LA and Irvine Valley. Over the past 12 months, there were sixteen other related program recommendation requests from regional community colleges.

 $^{^2}$ Five-year change represents new job additions to the workforce. Annual openings include new jobs and replacement jobs that result from retirements and separations.

³ Entry-level wage is defined as the twenty-fifth percentile hourly wage. Wages for experienced workers are defined as the seventy-fifth percentile hourly wage.

Non-Community College Supply—Although these occupations typically do not require a bachelor's degree, it is important to consider the supply from non-community college institutions in the region that provide training programs for middle-skill accounting occupations. Exhibit 3 shows the annual and three-year average number of awards conferred by these institutions in the related Classification of Instructional Programs (CIP) Code: 52.0302 - Accounting Technology/Technician and Bookkeeping. Due to different data collection periods, the most recent three-year period of available data is from 2013 to 2016. Between 2013 and 2016, non-community college institutions conferred an average of 17 awards.
