The Orange County Center of Excellence for Labor Market Research (COE) prepared this report to provide Los Angeles/Orange County regional labor market supply and demand data for four occupations related to education. To illuminate which occupations are immediately accessible to community college graduates, these education occupations have been divided into middle-skill and above middle-skill occupation groups. Middle-skill occupations typically accommodate community college graduates, while above middle-skill occupations typically require a four-year degree and/or prior work experience. The **middle-skill** group of education occupations in this report includes preschool teachers, except special education (25-2011), teaching assistants, except postsecondary (25-9045), and childcare workers (39-9011). The **above middle-skill** education occupation is education and childcare administrators, preschool and daycare (11-9031). This report is intended to help determine whether there is demand in the local labor market that is not being met by the supply from community college programs that align with the relevant occupations.

Based on the available data, there appears to be a supply gap for the middle-skill group of education occupations in the region. While more than one-third of current workers in the field have completed some college or an associate degree, entry-level wages are lower than the living wage in both Los Angeles and Orange counties. Therefore, due to some of the criteria being met, the COE endorses this proposed program. Detailed reasons include:

Demand:

- Supply Gap Criteria Over the next five years, there is projected to be 18,985 jobs available annually in the region due to retirements and workers leaving the field, which is more than the 6,210 awards conferred annually by educational institutions in the region.
- Living Wage Criteria Within Orange County, all the annual job openings for these middle-skill education occupations have entry-level wages below the county's living wage (\$17.36/hour).¹
- Educational Criteria Within the LA/OC region, 62% of the annual job openings for middle-skill occupations related to education typically require a high school diploma.
 - However, the national-level educational attainment data indicates between
 37.8% and 39.1% of workers in the field have completed some college or an associate degree.

Supply:

- There are 27 community colleges in the LA/OC region that issue awards related to the education occupations in this report, conferring an average of 4,626 awards annually between 2017 and 2020.
- Between 2016 and 2019, there was an average of 1,584 awards conferred annually in related training programs by non-community college institutions throughout the region.

Occupational Demand

Exhibit 1 shows the five-year occupational demand projections for the middle-skill group of education occupations in this report. In Los Angeles/Orange County, the number of jobs related to these occupations is projected to decrease by 2% through 2024. However, there will be nearly 19,000 job openings per year through 2024 due to retirements and workers leaving the field.

This report includes employment projection data by Emsi which uses EDD information. Emsi's projections are modeled on recorded (historical) employment figures and incorporate several underlying assumptions, including the assumption that the economy, during the projection period, will be at approximately full employment. To the extent that a recession or labor shock, such as the economic effects of COVID-19, can cause long-term structural change, it may impact the projections. At this time, it is not possible to quantify the impact of COVID-19 on projections of industry and occupational employment. Therefore, the projections included in this report do not take the impacts of COVID-19 into account.

Exhibit 2 shows the five-year occupational demand projections for the above middle-skill education occupation in this report. In Los Angeles/Orange County, the number of jobs related to this occupation is projected to decrease by 2% through 2024. However, there will be nearly 200 job openings per year through 2024 due to retirements and workers leaving the field.

Wages

The labor market endorsement in this report considers the entry-level hourly wages for both the middle-skill and above middle-skill education occupations in this report in Orange County as they relate to the county's living wage. Los Angeles County wages are included below in order to provide a complete analysis of the LA/OC region. Detailed wage information, by county, is included in Appendix A.

Orange County— All of the annual openings for the middle-skill group of education occupations have entry-level wages below the living wage for one adult (\$17.36 in Orange County). Typical entry-level hourly wages are in a range between \$12.04 and \$14.95. Experienced preschool teachers, except special education and teaching assistants, except postsecondary can expect to earn wages between \$18.66 and \$20.83, which are higher than the living wage estimate; however, experienced childcare workers earn less than the county's living wage (\$15.63). Orange County's average wages are below the average statewide wage of \$16.58 for these occupations.

Typical entry-level hourly wages for the above middle-skill occupation, education and childcare administrators, preschool and daycare, are \$18.10, which is above the living wage for one adult in Orange County. Experienced workers in this occupation can expect to earn \$26.91. Orange County's average wages are below the average statewide wage of \$26.82 for this occupation.

Los Angeles County— All of the annual openings for the middle-skill group of education occupations have entry-level wages below the living wage for one adult (\$15.04 in Los Angeles County). Typical entry-level hourly wages are in a range between \$12.00 and \$14.92. Experienced workers can expect to earn wages between \$15.88 and \$20.77, which are higher than the living wage estimate. Los Angeles County's average wages are below the average statewide wage of \$16.58 for these occupations.

Typical entry-level hourly wages for the above middle-skill occupation, education and childcare administrators, preschool and daycare, are \$18.14, which is above the living wage for one adult in Orange County. Experienced workers in this occupation can expect to earn \$27.72. Los Angeles County's average wages are below the average statewide wage of \$26.82 for this occupation.

Job Postings

There were 8,823 online job postings related to the middle-skill group of education occupations listed in the past 12 months. The highest number of job postings were for preschool teachers, infant/toddler teachers, assistant teachers, instructional assistants, and Montessori teachers. The top skills were: teaching, child care, early childhood education, child development, and cardiopulmonary resuscitation (CPR). The top three employers, by number of job postings, in the region were: Placentia Yorba Linda Unified, KinderCare, and Learning Care.

It is important to note that the job postings data included in this section reflects online job postings listed in the past 12 months and does not yet demonstrate the impact of COVID-19. While employers have generally posted fewer online job postings since the beginning of the pandemic, the long-term effects are currently unknown.

Educational Attainment

The Bureau of Labor Statistics (BLS) lists the following typical entry-level education levels for the occupations in this report:

- High school diploma: Childcare workers
- Some college/no degree: Teaching assistants, except postsecondary
- Associate degree: Preschool teachers, except special education
- Bachelor's degree: Education and childcare administrators, preschool and daycare

In the LA/OC region, the majority of annual job openings for the middle-skill group of education occupations in this report (62%) typically require a high school diploma. However, the national-level educational attainment data indicates between 37.8% and 39.1% of workers in the field have completed some college or an associate degree as their highest level of education. Of the 57% of middle-skill education job postings listing a minimum education requirement in Los Angeles/Orange County, 67% (3,359) requested a high school diploma and 33% (1,665) requested an associate degree.

Educational Supply

Community College Supply—Exhibit 3 shows the three-year average number of awards conferred by community colleges in the related TOP codes: Educational Aide (Teacher Assistant) (0802.00), Special Education (0809.00), Child Development/Early Care and Education (1305.00), Preschool Age Children (1305.40), The School Age Child (1305.50), Child

Development Administration and Management (1305.80), and Infants and Toddlers (1305.90). The colleges with the most completions in the region are: Rio Hondo, Santa Ana, and East LA. Over the past 12 months, there were 21 other related program recommendation requests from regional community colleges.

Non-Community College Supply—For a comprehensive regional supply analysis, it is also important to consider the supply from other institutions in the region that provide training programs for the education occupations in this report. Exhibit 4 shows the annual and three-year average number of awards conferred by these institutions in the related Classification of Instructional Programs (CIP) Codes: Special Education and Teaching, General (13.1001), Early Childhood Education and Teaching (13.1210), Child Development (19.0706), and Child Care Provider/Assistant (19.0709). Due to different data collection periods, the most recent three-year period of available data is from 2016 to 2019. Between 2016 and 2019, four-year colleges in the region conferred an average of 1,584 awards annually in related training programs.
