

# Addictive Disorders Counseling (Alcohol and Controlled Substances TOP: 2104.40)

## February 2022

Prepared by the South Central Coast Center of Excellence for Labor Market Research

#### **Program Recommendation**

This report was compiled by the South Central Coast<sup>1</sup> Center of Excellence to provide regional labor market data for the program recommendation – Alcohol and Controlled Substances. This report can help determine whether demand in the local labor market is not being met by the supply from programs of study (CCC and non-CCC) that align with this occupation group.

# **Key Findings**

- In the South Central Coast region, the number of jobs related to Alcohol and Controlled Substances are
  expected to increase for both selected occupations: Substance Abuse and Behavioral Disorder
  Counselors and Mental Health and Substance Abuse Social Workers.
- Alcohol and Controlled Substances is anticipated to experience a low risk of automation for both related occupations.
- In 2020 there were 1,939 regional completions in programs related to the occupations identified as related to Alcohol and Controlled Substances and 325 openings, indicating an **oversupply**.
- Typical entry-level education is a Bachelor's degree for Substance Abuse and Behavioral Disorder Counselors, and a Master's degree with residency for Mental Health and Substance Abuse Social Workers.
- The most common middle-skill jobs for TOP 2104.40 are Social and Human Service Assistants and Community Health Workers.
- Completers of Alcohol and Controlled Substances programs from the 2018-2019 academic year, in the South Central Coast region, had a **median annual wage upon completion** of \$26,036.
- 59% of students are employed within a year after completing a program.
- 29% of students attained a living wage within a year of completion.
- +33% change in earnings for completers.
- 71% of students were part-time, 9% skill builders, 47% first-generation, and 92% economically disadvantaged.

# **Occupation Codes and Descriptions**

There are two occupations in the standard occupational classification (SOC) system that were requested as aligned with Alcohol and Controlled Substances for this analysis. The occupation titles and descriptions, as well as reported job titles, are included in Exhibit 1.

### **Current and Future Employment**

In the South Central Coast region, the number of jobs related to Alcohol and Controlled Substances are expected to increase for both selected occupations.

### **Earnings**

In the South Central Coast region, the average wage for the listed occupations is \$28.27 per hour.

Exhibit 3 contains hourly wages and annual average earnings for these occupations. Entry-level hourly earnings are represented by the  $25^{\text{th}}$  percentile of wages, median hourly earnings are represented by the  $50^{\text{th}}$  percentile of wages, and experienced hourly earnings are represented by the  $75^{\text{th}}$  percentile of wages, demonstrating various levels of employment.

### **Employer Job Postings**

In this research brief, real-time labor market information is used to provide a more nuanced view of the current job market, as it captures job advertisements for occupations relevant to the field of study. Employer job postings are consulted to understand who is looking within the field, and what they are looking for in potential candidates. To identify job postings related to Alcohol and Controlled Substances the following standard occupational classifications were used:

21-1023	Mental Health and Substance Abuse Social Workers

## **Top Occupations**

In 2019, there were 85 employer postings for occupations related to Alcohol and Controlled Substances.

### **Top Titles**

#### **Student Outcomes**

The CTE LaunchBoard provides student outcome data on the effectiveness of CTE programs. The following student outcome information was collected from current students and exiters of regional Alcohol and Controlled Substances programs (TOP: 2104.40) for the 2018-19 academic year.

- The most common middle-skill jobs for TOP 2104.40 are Social and Human Service Assistants and Community Health Workers.
- Completers of Alcohol and Controlled Substances programs from the 2018-2019 academic year, in the South Central Coast region, had a **median annual wage upon completion** of \$26,036.
- 59% of students are **employed within a year** after completing a program.
- 29% of students attained a living wage within a year of completion.
- +33% change in earnings for completers.
- 71% of students were part-time, 9% skill builders, 47% first-generation, and 92% economically disadvantaged.

#### **Notes**

Data included in this analysis represent the labor market demand for relevant positions most closely related to Alcohol and Controlled Substances. Traditional labor market information was used to show current and projected employment based on data trends, as well as annual average awards granted by regional community colleges. Real-time labor market information captures job post advertisements for occupations relevant to the field of study and can signal demand and show what employers are looking for in potential employees, but is not a perfect measure of the number of open positions. All representations have been produced from primary research and/or secondary review of publicly and/or privately available data and/or research reports. The most recent data available at the time of the analysis was examined; however, data sets are updated regularly and may not be consistent with previous reports. Efforts have been made to qualify and validate the accuracy of the data and findings; however, neither the Centers of Excellence for Labor Market Research (COE), COE host district, nor California Community Colleges Chancellor's Office are responsible for the applications or decisions made by individuals and/or organizations based on this study or its recommendations.
