- College of the Desert The deans discussed enrollment patterns and it appears that students are staying online when given an opportunity.
- Crafton/SBVC enrollments are down. It appears that CTE enrollments may have improved. Students can choose if they want to be online or in class face to face (High Flex program - lecture and lab live with student participation). SBVC started planning in Spring 202. They are looking at supplying every classroom with the technology to do the High Flex program. Kenny Melancon shared information on the technology faculty is using for their online classes. Students are engaged in the format.
- VVC No exact numbers for CTE enrollments
- RCC enrollments are low. Plan on offering late start classes in October (60% online 40% face to face)
- Palo Verde enrollment was up but there were some problems with textbooks and that caused numbers to drop.
- MSJC waiting to get exact enrollment numbers
- Norco is using High Flex and Owl.
- College's COVID policies
 - MSJC BOT vaccine mandates with a November deadline. Spring 2022 required unless there is a medical or religious exemption.
 - COD Strict entry policy, masking, and social distancing.
 - Chaffey BOT mandating vaccine. BOT deadline of October 15, 2021. Administration is "working out the details". Spring 2022 onward mask requirements.
 - Palo Verde no vaccine mandate. Following CAL OSHA mandates.
 - Crafton/SBVC No vaccine mandate. In class a mask is required.
 - VVC Students will receive an incentive if they get vaccinated. Mask mandate in all classrooms.
 - Barstow Vaccine clinics. Masks required inside the classroom.
 - RCCD BOT issued a vaccine mandate. To be on any RCCD campus or building you must be vaccinated. Those who have the first vaccine need to do weekly testing. Masking is required inside all district locations.

Regional Director Update:

- Wendy Dearas shared that she is hosting a PD six session series (five left) best practices for English language learners (details in the IEDRC newsletter).
