The grant needs a letter of support and partner colleges. The grant has a 5-year performance period. 2 <sup>nd</sup> - item is a Climate and Water in Ag grant coming from UC San Diego. The application would take a

Challenge Grant	research type approach to Ag/Water, externships with various colleges and needs letter of support and partner colleges.
	Becky mentioned she is having a hard time committing to support these grants because she is already committed to local applications. Jessica said that it's not necessary to have every college buy in, just the consortium support. Pedro suggested that the letter come from the colleges in the region that want to participate, not necessarily all colleges.
	David asked what the political tone would be for the ag grant. Jessica said there is no political bent against ag. It would provide externships for ag faculty to develop curriculum and allow students get research opportunities around the work.
	David asked what the idea was behind supporting this grant if only a few colleges are involved. Tony said that that the grant is looking for regional support, and this is the body that provides regional support. Because it is non-binding for individual colleges in the consortium, we are able to support. Jessica mentioned that it is written in a way that would allow for colleges to come on in the future. Becky said she is open to supporting regional cohesion, but not specific projects and would like to have colleges that have committed on agenda in future.

Jessica mentioned that Kern and SCCCD are collaborating on the fiscal transition. The contract is being presented to both district boards and they are communicating with partners and vendors on transition items. Jessica said that the invoicing process will change and a memo will go out to notify everyone about new, streamlined process. Janice mentioned she and Daniel are in a 25% position until June of 2022 at least and that they may

She said that K12 SWP round 1 will stay with SCCCD. Kern will take rounds 2-4. For college SWP SCCCD keeps round 1-5, Kern takes round 6. Jessica spoke about her plans for 2022 and began by highlighting that the foundational infrastructure of the consortium is the Comprehensive Learning Needs Assessment. She will provide connections to projects as part of strategic plans to cover both K12 and colleges. Her vision moving forward is to anchor this to regional planning/data to understand gaps in industry sectors and provide access and work-based learning opportunities. She also mentioned that the CRC will be updating its regional plan and looking for
	opportunities to increase partnership footprint. She also acknowledged the ongoing challenge of moving forward during the pandemic. Jonna mentioned that she felt like COS is at capacity with some of their healthcare provider programs. Tony mentioned that these grants could be used to expand capacity of certain programs that need more support and that he would support building additional capacity for healthcare/RN programs. Pedro mentioned that healthcare programs work together and can supplement students learning on their way to getting their RN. Pedro also mentioned it may be prudent to concentrate resources in certain programs/colleges when it makes sense. The focus should be to have an impact, not to be split evenly between colleges.
